## RESOLUTION AUTHORIZING DESIGN SERVICES CONTRACT WITH MOFFATT & NICHOL ENGINEERS FOR OSPREY RIDGE STORM WATER PUMP

**Whereas**, there are continuing storm water flooding concerns in the Osprey Ridge neighborhood, and

**Whereas**, the Town seeks to resolve these concerns with the installation of a fixed storm water pump station in the Osprey Ridge neighborhood, with discharge into the Town's storm water system in the adjacent Emerald Isle Woods Park, and

**Whereas**, the Board of Commissioners recently identified the construction of this project as its top priority for the FY 16-17 budget, and the Town hopes to begin construction of the new storm water pump station soon after the start of FY 16-17, and

**Whereas**, the execution of a design contract now will enable construction to begin earlier in FY 16-17, and

**Whereas**, the Town has utilized the services of Moffatt & Nichol Engineers, Raleigh, NC, for the design of the entire Coast Guard Road storm water system, which includes 8 fixed pump stations discharging to Emerald Isle Woods Park, and

**Whereas**, Moffatt & Nichol Engineers has provided a proposal to complete this work for the Town, with a target date of September 13 for a construction contract award by the Board of Commissioners, and

**Whereas**, the Town Manager is the chief administrative officer for the Town,

**Now, therefore, be it resolved** by the Board of Commissioners that the Town Manager is hereby authorized to execute a contract with Moffatt & Nichol Engineers, Raleigh, NC, in the amount of \$24,888 for design services for a new storm water pump station to serve the Osprey Ridge subdivision. The Town Manager is authorized to approve change orders up to \$10,000, and any change orders greater than \$10,000 will be presented to the Board of Commissioners for consideration.
