## RESOLUTION AUTHORIZING PRE-POSITIONED HURRICANE DEBRIS REMOVAL CONTRACT

**Whereas**, it is advantageous for the Town to enter into a pre-positioned debris removal contract prior to hurricane season, and

**Whereas**, the Town conducted a formal bid process for this service, and received 7 bids for this work, and

**Whereas**, Four Points Recycling, LLC / Rhem Insulation, Inc. (Joint Venture), Jacksonville, NC, is the overall low bidder, and

**Whereas**, Four Points / Rhem has been evaluated by the Town's FEMA contractor regarding their ability to perform this type of work, and research indicates that the firm has significant experience, assets and personnel, and subcontractor relationships to complete the work in a timely and quality manner, and

**Whereas**, it is also wise to have a "second call" contractor available if Four Points / Rhem does not perform, and

**Whereas**, Morton Trucking, Inc., Jacksonville, NC, is the overall second lowest bidder, and would serve as the Town's "second call" contractor, and

**Whereas**, the Town Manager is the chief administrative officer of the Town,

**Now, therefore, be it resolved** by the Board of Commissioners that the Town Manager is hereby authorized to execute a pre-positioned hurricane debris removal contract with Four Points Recycling, LLC / Rhem Insulation, Inc. (Joint Venture), Jacksonville, NC, at unit costs specified in the attached bid tabulation.

**Be it further resolved** that the Town Manager is hereby authorized to execute a pre-positioned hurricane debris removal contract with Morton Trucking, Inc., Jacksonville, NC at unit costs specified in the attached bid tabulation as the "second call" contractor in the event that Four Points / Rhem fails to perform.
