### Please Read Carefully

Horses, mules, donkeys, or other members of the equidae or equus asinus families shall only be allowed on the beach strand with a valid permit. For the purposes of this permit these animals will be referred to as a horse. Permit holders and member of their party shall be subject to the following rules & regulations;

- Horse shall only be allowed on the beach strand between September 15 and April 30 of each year;
  - From 5:00 a.m. until 9:00 p.m. daily on days subject to daylight savings time.
  - From 5:00 a.m. until 7:00 p.m. daily on days subject to Eastern standard time.
  - Horses are not permitted on the beach strand from April 15<sup>th</sup> through April 24<sup>th</sup> (coincides w/beach driving)*
- Day-Permits** are only valid for the day issued.
- Seasonal-Permits** are valid from the date of issue through April 30, 2022.
- Horses shall remain (50) feet from the toe of any dune or vegetation line.
- Horses must be equipped with a properly installed bun bag or a manure catcher.
- Permit holders/horses may access the beach via the Black Skimmer Ramp (by Police Dept) or the East Ramp (at the Dog Leg). You may only use the town street right-of-way to travel directly to and from the nearest public parking area to the closest authorized vehicle access ramp.
- Pedestrians on the roadway or the beach strand have the right of way.
- A negative Coggins test taken within the last 12 months must be provided for each animal (N.C.G.S. 106-405.17 and NCAC 52B.0406.)
- Any violations of the rules and regulations may result in a civil citation or revocation of permit(s).
